Aggressor Fleet Terms and Conditions:

Deposit Policy:

Individuals: 40% of the charter rate is due within 14 days of the reservation. Final payment is due ninety (90) days prior to departure.

Groups (1/2 boat or more): A non-refundable, non transferable deposit of \$1500 accompanied by a signed contract is required within 14 days of the reservation. Reservation will only be confirmed with signed contract.

Aggressor Fleet Cruise Application & Waiver Policy: The Cruise Application/Waiver, found under 'Downloads', must be fully completed, signed (digitally or manually) and received by the Reservations Center ninety (90) days prior to departure date. Many Aggressor destinations are required to submit passenger information for itinerary approval. Passengers who fail to comply will be canceled and denied boarding. For those passengers traveling on back to back charters, a Cruise Application/Waiver must be completed and signed for each trip. If a reservation is made (90) days or less prior to the charter date, completed and signed Cruise Application/ Waiver must accompany full payment in accordance with the payment policies to confirm reservation.

Final Documents Package: After receipt of your final payment, you will receive a **final documents package**. This package contains luggage tags which will help the crew identify your bags. Prior to your departure, please download a current "**Know Before You Go**" by going to www.aggressor.com to the "Download" section of the website to print a copy. You will not receive a voucher as proof of payment for the charter.

*The following information is important.
Please read carefully.*

ARRIVAL & BOARDING THE BOAT

If you arrive in Belize on the day of your charter, you will be met at the airport by Discovery Expeditions. If you are already in Belize, please make your way to the Belize Aggressor III any time after 2:00 p.m. on Saturday. The Belize Aggressor III docks at the Radisson Fort George Hotel in Belize City.

We highly recommend you pack a regulator, mask, fins, swimsuit, change of clothes, toiletries and any medication you may need in your carry-on bag. Having these few items with you can make an unexpected luggage delay more bearable. Also, if you are taking camera equipment, we suggest you hand-carry it onto the plane.

BELIZE DIVING CONDITIONS

You will be diving in water that averages 78° - 82°F. Most guests make as many as 5 dives each day, so some sort of protection is needed. A 3mm wetsuit or shorty is recommended. All diving is directly from the mothership.

PASSPORTS, DOCUMENTATION, C-CARDS, & DIVE THE WORLD CLUB

Visitors must have a current passport, adequate funds to support themselves, and a return airline ticket to travel to Belize. US citizens require a passport which must be valid for 6 months from date of entry. It is the travelers' responsibility to ensure they have the proper documentation to travel to the destination and return to their country. Please check with the appropriate consulate to ensure you have the proper documentation. Always check your passport and visa requirements. US citizens may go to the US Department of State website at www.travel.state.gov for more information. **Aggressor Fleet cannot assume responsibility for passengers not having correct documentation.**

Remember to bring your C-Card or proof of certification. The divemaster requires proof of certification before the first dive.

If you are a repeat guest, you are automatically enrolled in Aggressor Fleet's Dive the World Club and will receive 10% off on-board services.

WAIVER & INSURANCE

Aggressor Fleet and the Belize Aggressor III require each guest to complete an application and waiver form prior to departure. It must be received by the Reservations Center at least 90 days prior to your departure date. You may complete one online by going to www.aggressor.com, and fax, email or scan to +1-985-384-0817 or belize@aggressor.com.

We highly recommend that scuba divers purchase a travel insurance policy through DiveAssure, Divers Alert Network or a policy of your choice. For coverage information, go to: www.aggressor.com.

COMMUNICATIONS IN BELIZE

The Belize Aggressor III is in constant communication with their local agent. In the event of an emergency, family and friends may contact the yacht on Friday or Saturday by dialing 011-501-224-5322, Discovery Expeditions at 011-501-223-0748 or by e-mailing the boat at: master.belizeaggressor@telaurus.net. The emergency cell phone number at the Reservations Center is +1-985-714-1300. There is a satellite phone onboard; however, it does not have a recorder. Phone cards can be purchased onboard to make phone calls or send/receive e-mails.

FEES & TAXES

Each guest must pay a \$95 US port fee (includes cruising tax and park fee) at the end of the charter when settling your bill. These may be paid by Visa, MC, AMEX, cash or Travelers Checks. A departure tax of \$35 US per person will be collected at the airport when departing (cash).

SHIPS BOUTIQUE & CREDIT CARDS

There is a mini-boutique onboard with assorted t-shirts, shorts, batteries and miscellaneous items. Due to the uncertainty of availability in Belize, we highly recommend you bring extra batteries and supplies you may need. The Belize Aggressor III accepts Visa, MasterCard, and American Express. Traveler's checks are welcome with no service charge. Sorry, no personal checks.

***CREDIT CARD USERS:** Many credit card companies are charging a conversion fee. If this happens to you, please contact your credit card company directly.

FRIDAY

Friday afternoon, the Belize Aggressor III returns to Belize City at approximately 1:00 p.m. to provision and fuel the yacht. This is your opportunity to shop, visit the Belize Zoo, go Cave Tubing, or tour a Mayan Ruin. These tours may be booked by info@liveboardvacations.com or once onboard by the Captain. Any onboard charges are settled with the Captain on this day. The Belize Aggressor III crew will host a sunset cocktail party Friday evening. The crew will assist you in recommending dinner at a local Belize restaurant.

CREW GRATUITY

Gratuities are voluntary and based upon the quality of service the crew has provided. When settling your account on the final day of the trip, the Captain will have an

envelope for gratuities, to be divided equally among the crew.

CHECKOUT

If you don't have plans to extend your stay in Belize, we recommend an early morning departure. Checkout time is between 7:00 and 8:00 a.m. on Saturday. The crew will arrange transportation for you to the airport or to your hotel, (in Belize City) if you are planning to extend your vacation.

SAMPLE ITINERARY

SATURDAY: Afternoon arrivals are met at the airport and transferred to the Belize Aggressor III. If you arrive in the morning, you will be transported to the Radisson Fort George Hotel and your luggage will be taken to the boat. At 6:00 p.m. dinner is served onboard followed by the Captain's briefing and a welcome party.

SUNDAY-THURSDAY: Eat, Sleep, Dive aboard the Belize Aggressor III.

FRIDAY: Diving ends Friday morning. At approximately 1:00 p.m. the Belize Aggressor III returns to Belize City. 6:00 p.m. cocktail party onboard. 7:00 p.m. Dinner at a local restaurant.

SATURDAY: 8:00 a.m. checkout. Guests are transferred to the airport.
