Deposit Policy:

Individuals: 40% of the charter rate is due within 14 days of the reservation. Final payment is due ninety (90) days prior to departure.

Groups (1/2 boat or more): A non-refundable, non transferable deposit of \$1500 accompanied by a signed contract is required within 14 days of the reservation. Reservation will only be confirmed with signed contract.

Cruise Application/Waiver Policy: The Cruise Application/Waive, found at www.aggessor.com under the 'Download' section must be fully completed, signed (digitally or manually) and received by the Reservations Center at least ninety (90) days prior to departure date. Many Aggressor destinations are required to submit passenger information for itinerary approval. Passengers who fail to comply will be canceled and denied boarding. If a reservation is made (90) days or less prior to the charter date, completed and signed Cruise Application/ Waiver must accompany full payment in accordance with the payment policies to confirm reservation.

Final Documents Package: After receipt of your final payment, you will receive a **final documents package**. This package contains luggage tags which will help the crew identify your bags. Prior to your departure, please download a current "**Know Before You Go**" by going to www.aggessor.com to the "Download" section of the website to print a copy. You will not receive a voucher as proof of payment for the charter.

Please read it carefully.*

ARRIVAL & BOARDING

If you arrive in Providenciales (Provo) on the day of your charter, you will be met at the airport by a uniformed crewmember. If you are already on the island, please make your way to the Turks & Caicos Aggressor, anytime after 3:00

p.m. on Saturday. Guests arriving on early Saturday flights may store their luggage onboard and come back at 3:00 p.m. The crew needs this time to prepare for the charter. The Turks & Caicos Aggressor docks, weather permitting, at the Turtle Cove Marina in Providenciales.

We highly recommend you pack a regulator, mask, fins, swimsuit, change of clothes, toiletries and any medication you may need in your carry-on bag. Having these few items with you can make an unexpected luggage delay more bearable.

TURKS & CAICOS DIVING CONDITIONS

You will be diving in water that averages 78-84°F. Most guests make up to 5 dives a day, so some sort of protection is needed. A 3mm wetsuit or shorty is recommended. All diving is directly from the mother ship.

PASSPORTS, DOCUMENTATION, C-CARDS, and DIVE THE WORLD CLUB

Visitors must have a current passport, adequate funds to support themselves, and a return airline ticket to travel to the Turks & Caicos. US citizens require a passport which must be valid for 6 months from date of entry. It is the travelers' responsibility to ensure they have the proper documentation to travel to the destination and return to their country. Please check with the appropriate consulate to ensure you have the proper documentation. Always check your passport and visa requirements. US citizens may go to the US Department of State website at www.travel.state.gov for more information. ***The Reservation Center cannot assume responsibility for passengers not having correct documentation.***

Be sure to bring your C-card or proof of certification. The divemaster requires proof of certification before the first dive.

If you are a repeat guest, you are automatically enrolled in the Dive the World Club and will receive 10% off on-board services.

WAIVER & INSURANCE

The Reservations Center and the Turks & Caicos Aggressor II require each guest to complete a Cruise Application and waiver form, prior to departure and diving. You may complete it online by going to www.aggessor.com and email it to assistant@aggessor.com.

We highly recommend travelers purchase travel insurance and dive insurance. For information go to: www.aggessor.com.

FEES AND TAXES

A \$45 US per person bed tax is collected at the end of the week when you settle your tab. In addition, there is a \$23 airport departure tax. These fees are not included in the charter rate and are subject to change without notice.

SHIPS BOUTIQUE & CREDIT CARDS

There is a mini-boutique on board with assorted t-shirts, shorts, batteries and miscellaneous items. Due to the uncertainty of availability in Provo, we highly recommend you bring extra batteries and supplies you may need. The Turks & Caicos Aggressor II accepts Visa, MasterCard and Travelers Checks. Sorry, no personal checks.

***CREDIT CARD USERS:** Many credit card companies are charging a conversion fee. If this happens to you, please contact your credit card company directly.

FRIDAY

Friday afternoon, the Turks and Caicos Aggressor II returns to Provo around noon to provision and fuel for the following week. This is your opportunity to shop, sightsee, relax or check e-mail (wireless is available at the dock). The Turks and Caicos Aggressor hosts a sunset cocktail party Friday evening at 5:30 p.m., then dinner ashore which is the only meal not provided with the cruise. Provo has 5 restaurants within walking distance.

TIPS ONBOARD

Gratuities should be voluntary and based upon the quality of service the crew has provided. When settling your account on the final day of the trip, the Captain will have an envelope for gratuities, which will be divided equally among the crew.

CHECKOUT

If you don't have plans to extend your stay in Provo, we recommend an early morning departure. Checkout time is between 7:00 a.m. and 8:00 a.m. on Saturday.

- 1.) **EARLY SATURDAY MORNING DEPARTURES:** The taxi will pick guests up between 5:45 a.m. – 6:15 a.m. A continental breakfast is available.

- 2.) **ALL OTHER DEPARTURES:** Guests must depart the boat at 8:00 a.m. so that the crew may provision for the next charter. Guests may store their luggage on board. A taxi will meet the guests at a designated meeting area between 11:00 a.m. – 11:30 a.m.

SAMPLE ITINERARY

SATURDAY: Afternoon arrivals are met at the airport and transferred to the Turks & Caicos Aggressor II. Dinner is served on board at 6:30 p.m. followed by the Captain's briefing. Guests arriving earlier must make arrangements with the Aggressor office for transfers. Diving begins Sunday morning.

SUNDAY - THURSDAY: Eat, Sleep, Dive aboard the Turks & Caicos Aggressor II.

FRIDAY: Diving ends Friday morning. At approximately noon the Turks & Caicos Aggressor returns to Turtle Cove Marina. Sightseeing, shopping is available or wireless internet at the dock. The yacht hosts a cocktail party for you at 5:30 p.m. Dinner at a local restaurant is at 6:30 p.m. There are 5 restaurants in walking distance from Turtle Cove.
